## **Notes:**

- a) Shareholders whose names appear in the Depository Register/ Share Register on the '**Record Date**' i.e. **June 12, 2016** shall be eligible to attend the 30<sup>th</sup> Annual General Meeting (AGM) and receive the **Dividend**.
  - b) The Board of Directors recommended **Cash Dividend of 18 percent** or **Tk.1.80 per share of Tk.10/- each** for the year 2015.
  - c) In accordance with the Articles of Association of the Company Directors shall retire at the AGM for the year 2015 and may, if eligible, offer themselves for re-election.
  - d) A member entitled to attend and vote at the AGM may appoint a proxy who **must** be a shareholder of the Company to attend and vote in his/her stead. The "Proxy Form", duly filled & stamped at **Tk.20/-** must be deposited at the Registered Office of the Company no later than 48 (forty eight) hours before commencement of the AGM.
  - e) Shareholders bearing BO ID number are requested to update their respective BO ID with **12 Digits Taxpayer's Identification Number (e-TIN), Bank Account, address and Mobile Number** etc. through their Depository Participant (DP) before the '**Record Date**'.
  - f) Shareholders bearing Folio Numbers are requested to submit their **12 Digits Taxpayer's Identification Number (e-TIN)** to the Share Department of the Company before the '**Record Date**'; failing which Income Tax at Source will be deducted from cash dividend @ 15% instead of 10% as per Income Tax Ordinance 1984 under section 54.
  - g) **The concerned Brokerage Houses are requested to provide us with a statement with the details (Shareholder name, BO ID number, client-wise shareholding position, gross dividend receivable, applicable tax rate, and net dividend receivable) of their margin loan holders who holds Delta Life shares, as on the 'Record Date', along with the name of the contact person in this connection, to the Company's Share Department on or before June 16, 2016. The Brokerage Houses also requested to provide us with their Bank Account name & number, routing number etc.**
  - h) In case of non-receipt of Annual Report -2015 of the Company sent through courier, Members may collect the same from the Company's Share Dept. within June 26, 2016.
